

2.	Minutes of the previous meeting	The minutes for the previous meeting held on 9 th September 2016 were approved.

3.1	MedSin funding	MedSin asking for funding for future conference. National & international society. 3 years a society at BSMS. Applied to host MedSin autumn weekend, coming up on 15-16 th October. This year's theme: gender equality and health. Good opportunity to grow BSMS MedSin & for students to get involved at a national level. Training workshops & talks by external speakers. Checkland building – awaiting confirmation; workshops, training, social Sat evening. Host students from around the country. Food, travel subsidiaries, venue out of hours. 60-80 attendees £1500-1600 total, £15 event ticket, £10 from those far away, cheaper tickets for those hosting. 60 attendees = £1000, so short of £500. In contact with USSU, but can't get any funding until week 3-4 (waiting on societies committee formation), MPU, MPS have also been applied to for money. Applying for £200 from MedSoc. Last year, spring event was held in Norwich, autumn was Cardiff. Norwich had large proportion funding from Students Union, rest was from ticket sales. JB: how much money can USSU give? Big opportunity for them ES: can you get money from USSU and Uni of Brighton SU - £200 from each possibly. Each society entitled to £150, so extra £50. Deadline for funding debated. Will decide by Thursday next week how much funding they will get – maximum £200 (not including the £150 each society gets). MedSin: have tried for funding from Brighton, in previous

		experience has been very difficult to get funding from Brighton. BSMS has covered costs of travel previously, but encourages societies to apply through MedSoc initially. Was hoping for the £200 as extra to be able to apply for more events later on in the year. 60-80 people is an estimation of number that will attend. Structure of weekend is set by national committee, so there's things for both those able to vote and those who cannot. Open to everyone to attend, but not much publicity. GP suggests funding from the medical school as the Dean is keen to encourage conferences.	JB

Nurses was problematic because 2 main groups – those with children, those who are younger. For future healthcare socials – try different degrees e.g. biomed. 3.4	Monthly bulletin promotion	ES: plan to advertise non-medsoc socials monthly that people may be interested in, trying to compromise by catering for more people this way. Potential of side revenue by promoting certain events from certain promoters. Highlighting specific events on a calendar that we would use anyway in order to gain some extra money. Aim is to be transparent, and well established. Advertisement rather than selling the event. Part of the transparency would be a disclaimer. Not discussed yet with clubs, waiting for committee response. LC: those willing to promote events may want you to sell tickets GP: selling discounts vs. advertising.
